## **Man Charged After Dozens of Child Porn Images are Found on Phone**

August 22, 2023

### **Case Details:**

On August 17, 2023, a 25-year-old man was arrested after a search of his repossessed cellphone uncovered 66 “images and videos of babies, toddlers and teens engaged in sexual conduct” in his **iCloud** gallery. The man was charged with possession with intent to promote child pornography, a second-degree felony.



## **I-Team: Prosecutors Say Former Teacher Tried to Delete Videos of Child Sexual Abuse**

August 21, 2023

### **Case Details:**

On August 18, 2023, a 39-year-old former teacher was arrested charged with 5 counts of sexual exploitation of a minor and 1 count of possession of child pornography. According to the indictment, the FBI recovered 5 videos depicting the sexual abuse of a child from an allegedly deleted folder in the former teacher's **iCloud** account. News reports indicate that law enforcement has yet to review "dozens and dozens and probably hundreds of images" recovered from the former teacher's electronic devices.



## **Man Caught Planning to Child Sexual Abuse Material with Child (13) Back Behind Bars**

August 16, 2023

### **Case Details:**

On August 16, 2023, a 33-year-old man from Northern Ireland was arrested after chatting online with 2 undercover police officers. During those chats, the man sent 20 the officers at least 20 images containing CSAM that had been stored in his [iCloud](#) account.



## **Geek Squad Manager Arrested on More than 30 Charges Involving Child Pornography**

August 11, 2023

### **Case Details:**

On August 8, 2023, a 37-year-old man was arrested and charged with 25 counts of possession of child pornography. Police officers investigating the man found that he had created an **iCloud** Private Relay, which hid his IP address. Eventually, officers found that the man had saved 571 photos, the majority of which “were pornography related and focused on young girls.”



## **NYPD Cop Indicted After Child Pornography Depicting Kids as Young as 4 Found on iCloud Account**

July 7, 2023

### **Case Details:**

A 50-year-old former police officer was arrested on July 6, 2023 and charged with 50 counts of promoting a sexual performance by a child and 69 counts of possessing a sexual performance by a child. After receiving a tip that the man had uploaded CSAM to his **iCloud** account, law enforcement executed a search warrant and discovered images and videos of CSAM of children between the ages of 4 and 12 in his **iCloud** account and on his mobile phone.



## **Osage Beach Man Charged with Possession of Child Pornography**

June 29, 2023

### **Case Details:**

On June 28, 2023, a 27-year-old man was arrested after detectives received a tip regarding images of suspected child pornography being uploaded to a cellphone **iCloud** account. After receiving a search warrant and searching the man's **iCloud** account, law enforcement found images that were “graphic” and “depicted prepubescent children engaged in sexual activities.” The man was charged with 8 counts of possession of child pornography, a felony.





## **New Lexington Coach Accused of Posing as Girl on Snapchat to Get Boys to Send Nude Photos**

June 23, 2023

### **Case Details:**

On June 23, 2023, a 28-year-old former volleyball coach was arrested after law enforcement found that he communicated with and solicited nude images from middle school and high-school boys by pretending to be a teenaged girl. According to law enforcement officers, a forensic review of the man's **iCloud** account uncovered more than 100 images and videos of child sexual abuse material.



## **[WI] Milwaukee Man Accused of Child Sexual Exploitation Faces Additional Charges**

June 9, 2023

### **Case Details:**

On January 27, 2023, a 25-year-old man was arrested after he contacted a 14-year-old girl, convinced her to send him nude photos, and threatened to post the photos online unless she would have sex with him. Following that arrest, detectives seized the man's cell phone and obtained access to his **iCloud** and **Apple** messaging accounts. Review of those accounts uncovered additional sexually explicit videos of at least 1 other minor victim.



## Man Avoids Jail After Enjoying Watching Child Sexual Abuse

June 3, 2023

### **Case Details:**

On June 15, 2022, a 23-year-old man was arrested and charged with 3 counts of making indecent images of children and 1 count of possessing a prohibited image of a child. Law enforcement officers learned from **Apple** that the man had downloaded CSAM to his **iCloud** account. Law enforcement officers who searched the man's account reported that they found "179 still images and 41 moving of the worst type of Category A images, 141 still Category B images and 536 still and 1 moving Category C images. Coates also had 171 still and 11 moving prohibited images of children."



## **[Fed] Former Orange County Elementary School Teacher Pleads Guilty to Possessing Child Sexual Abuse Material**

May 15, 2023

### **Case Details:**

On May 15, 2023, a 24-year-old former teacher and wrestling coach pleaded guilty to possessing child sexual abuse material, including at least 1 video “portraying masochistic sexual conduct involving a child.” According to the man’s plea agreement, a forensic review of the man’s **iCloud** account identified at least 81 videos and 158 images of CSAM, including depictions of infants or toddlers and “violent, sadistic and masochistic conduct.”



## **[Fed] Port St. Lucie Tattoo Artist Pleads Guilty to Producing Child Sexual Abuse Material**

May 4, 2023

### **Case Details:**

On May 4, 2023, a 42-year-old man pleaded guilty to 3 counts of producing child sexual abuse material. The arrest came after law enforcement conducted a forensic examination of the man's electronic devices and **iCloud** account, which uncovered images and videos of him engaging in sexual activity with 3 minors, including a 13-year-old girl. The man also recorded himself having sex with two 17-year-old minors using his **iPhone**. On August 29, 2023, the man was sentenced to 480 months' imprisonment.



## **[Fed] Wesley Chapel Man Pleads Guilty to Exploiting and Producing Sexual Abuse Material Depicting Half a Dozen Children**

March 30, 2023

### **Case Details:**

On August 18, 2023, a 31-year-old man was sentenced to life after pleading guilty to enticement and coercion of a minor to engage in sexual activity, using minors to produce child sexual abuse images and videos, and possessing child sexual abuse material. According to law enforcement, between 2018 and 2020, the man coerced children between the ages of 13 and 17 to have sexual intercourse with him by pretending to be a minor online. During their investigation, law enforcement officers obtained a search warrant for the man's **iCloud** account, where they found approximately 30 videos and 81 images that Colborn had produced of himself sexually abusing young girls.



## **[Ill] Man Charged with Secretly Recording Child While She was in Shower at Fox Lake Residence**

March 21, 2023

### **Case Details:**

On March 16, 2023, a 32-year-old man was arrested and charged with 6 counts of unauthorized videotaping of a minor and 3 counts of child pornography. According to the criminal complaint, the man produced videos of a child showering by secretly placing a recording device in her bathroom. Law enforcement found 3 such videos on the man's [iCloud](#) account, leading to his arrest.



## **Ex-San Diego State Football Player Pleads Not Guilty to Child Porn Possession**

March 2, 2023

### **Case Details:**

On February 23, 2023, a 20-year-old former college football player was arrested and charged with 1 count of felony possession of child pornography. The man was 1 of 3 individuals investigated in connection with the alleged October 2021 rape of a 17-year-old at a house party. During the course of the investigation, investigators found 38 videos on the defendant's **iCloud** account depicting child sexual abuse material. Seven of those videos had been previously identified as child pornography by NCMEC. If convicted, the defendant faces up to 3 years in state prison and will be required to register as a sex offender for the rest of his life. The defendant has plead not guilty to the charges, which are still pending.





## **District Man Sentenced to 7 Years in Prison for Child Exploitation**

February 28, 2023

### **Case Details:**

On February 28, 2023, a 36-year-old man was sentenced to 7 years in prison after pleading guilty of distribution of child pornography.

According to court documents, law enforcement searched the man's **iCloud** account and found hyperlinks to "over 200 videos depicting the sexual abuse of very young children." The man admitted to trading images depicting the sexual abuse of young children over the internet.



## **Former Punahou Coach Long Accused of Sexually Assaulting Players is Arrested on Child Porn Charges**

February 2, 2023

### **Case Details:**

On February 2, 2023, a 50-year-old former basketball coach was arrested on child pornography charges. Court documents allege that the man possessed explicit photographs of 1 of the man's 17-year-old former players, who he also sent naked photos to and offered to pay for sex. Authorities who searched the man's **iCloud** account found pornographic images of the same victim. The man has plead not guilty to the charges, which are still pending.



## **Former Punahou Coach Long Accused of Sexually Assaulting Players is Arrested on Child Porn Charges**

February 2, 2023

### **Case Details:**

On February 2, 2023, a 50-year-old former basketball coach was arrested on child pornography charges. Court documents allege that the man possessed explicit photographs of 1 of the man's 17-year-old former players, who he also sent naked photos to and offered to pay for sex. Authorities who searched the man's **iCloud** account found pornographic images of the same victim. The man has plead not guilty to the charges, which are still pending.



## **Warehouse Worker Caught with Hundreds of Child Abuse Images Keeps Freedom**

January 14, 2023

### **Case Details:**

On November 30, 2020, a 28-year-old British man was arrested after a search of his home uncovered 646 child abuse images on his phone and **iCloud** account, including images showing children in distress and pain. The man ultimately pleaded guilty to 3 counts of making an indecent photo of a child and 1 charge of possessing extreme pornography.



## **Man Arrested for 15 Counts of Child Pornography**

December 15, 2022

### **Case Details:**

On December 15, 2022, a 24-year-old man was arrested and charged with 15 counts of felony pornography involving a juvenile after law enforcement received 2 cyber tips about the possible distribution of child pornography from NCMEC. Law enforcement obtained a warrant to search the man's **iCloud** account, which returned 13 videos of child pornography.



## **Marshall Man Charged for Possession of Child Pornography Due in Court**

September 11, 2022

### **Case Details:**

On July 5, 2022, a 24-year-old man was arrested and charged with 5 counts of a felony for possession of child pornography after NCMEC generated a Cybertip. After searching the man's cell phone and [iCloud](#) account, authorities located “ multiple images and videos of child sexual abuse material.”



## **Mount Pleasant Man Accused of Sex Trafficking Minor Allegedly Spent \$45K for Sex Acts, Drugs**

June 14, 2022

### **Case Details:**

In October of 2021, a 53-year-old man was indicted and charged with conspiracy to sex traffic minors, production of child pornography, and multiple counts of sex trafficking of a minor. The man is accused of trafficking a 17-year-old girl for months. A search of the man's **iPhone** and **iCloud** accounts uncovered 4 videos of the minor engaging in "commercial sex acts." The man was sentenced to 78 months in prison after pleading guilty to trafficking.



## **PA Man, 65, Busted on Child Porn Charges Again: DA**

May 5, 2022

### **Case Details:**

On April 28, 2022, a 65-year-old man was arrested and charged with 252 felony counts of possessing child pornography and 1 count of criminal use of a communications facility. The arrest came after **Apple** notified law enforcement that images containing CSAM were sent from an **iCloud** email account. A search of the man's account uncovered 8 photos of child pornography and 4 videos. The discovered material depicted girls between the ages of 3 and 12.





## **[STATE] Carlton County Child Sex Abuse Case Began with Report at Children’s Museum in St. Paul**

July 13, 2022

### **Case Details:**

On July 8, 2022, a 28-year-old man was arrested and charged with 5 counts of second-degree criminal sexual conduct, 5 counts of possession of child pornography, and 5 counts of felony use of a minor in sexual performance or pornographic work, all felonies. A few months earlier, he had been charged with 4 counts of production and attempted production of child pornography. According to court documents, the man, a licensed foster care provider, abused at least 6 children. During their investigation of the man, law enforcement identified approximately 99 images and 8 videos containing child sexual abuse material in the man’s **iCloud** account. Court documents state that the material “appeared to be homemade.” The man admitted to sexually abusing the children, all of whom were known to him, and producing the material found on his phone. The man told investigators that his “target range (for the victims) was 3–7 years old.”



## **[STATE] Monongahela Man Jailed for Child Pornography**

January 29, 2022

### **Case Details:**

On January 27, 2022, a 45-year-old man was arrested and charged with 50 felony counts of possession of child pornography after a search of the man's **iCloud** account uncovered "multiple images of child pornography."



## **[STATE] Reynoldsville Man Facing 87 Felony Charges Related to Alleged Child Pornography**

January 10, 2022

### **Case Details:**

On January 10, 2022, a 25-year-old man was arrested and charged with 63 counts of child pornography, 23 counts of dissemination of photo/film of child sex acts, and criminal use of a communication facility (87 felony charges overall). The investigation began after law enforcement received multiple tips from NCMEC indicating that a user was uploading CSAM. A search of the man's **iCloud** account was found to contain 10 images/videos of CSAM. The man admitted to investigators that he was interested in child pornography. The man was convicted and sentenced to prison on September 2, 2022.



## **[STATE] Former Bossier Cop Gets 20-Year Prison Sentence**

November 23, 2021

### **Case Details:**

A 40-year-old former police officer was arrested in December of 2018 after an investigation into another child pornography case that resulted in a federal indictment led law enforcement to the former officer. After performing a forensic examination of videos and images in the man's **iCloud** account, investigators uncovered images of pubescent and prepubescent children engaged in sexual activity, as well as videos of the man engaging in explicit sexual acts with his dog. After pleading guilty, the man was sentenced to 20 years in prison.



## **[STATE] Riverton Man Arrested in Child Pornography Investigation**

September 30, 2021

### **Case Details:**

On September 30, 2021, a 40-year-old man was arrested and charged with 100 counts of sexual exploitation after police found “hundreds” of images of suspected child pornography involving girls between the ages of 8 and 15 in his **iCloud** account. A search warrant covering the man’s **iCloud** account later uncovered more than 1,000 images of suspected child pornography, according to investigators. The man ultimately pleaded guilty to a second-degree felony charge of sexual exploitation of a minor and 2 counts of voyeurism, admitting to possessing pictures of nude minor females and to secretly taking photographs and videos of a minor without consent.



## **[FED] San Francisco Doctor Charged with Possessing Child Pornography in iCloud**

August 20, 2021

### **Case Details:**

On August 20, 2021, a 58-year-old doctor was charged with possessing child pornography after investigators found at least 2,000 sexually exploitative images and videos of children stored in his **iCloud** account. The man was ultimately indicted for 1 count of possession of child pornography. He pleaded guilty to the charge on January 9, 2023 and was sentenced to prison.



## **[STATE] Glendale woman Arrested After Child Porn was Found on her Phone; Suspect Tried to Send Love Note to Student**

July 30, 2021

### **Case Details:**

On July 29, 2021, a 19-year-old woman was arrested and charged with sexual exploitation of a minor after an investigation by law enforcement found a video containing child pornography in the woman's **iCloud** account. The woman admitted to downloading and sharing the video.



## **[STATE] Parker County Man Faces Felony Charges in Connection to Child Porn Case, Authorities Say**

July 26, 2021

### **Case Details:**

On July 21, 2021, a 46-year-old man was arrested and charged with 6 third-degree felony counts of possession of child pornography. According to law enforcement, a tip identified the man as possessing child pornography on his **iPad** and **iPhone**. After searching the man's **iCloud** account, investigators located about 1,000 photos of child pornography. The images depicted children between the ages of 6 and 12.





## **[STATE] Affidavit: San Antonio Man Arrested After Google Finds Explicit Images of Children Stored in iCloud**

September 21, 2020

### **Case Details:**

On September 21, 2020, a 49-year-old man was arrested and charged with 3 counts of possession of child pornography. The man's arrest came after the Texas Department of Public Safety Internet Crimes Against Children division received information about a Yahoo account that was storing explicit images of children on a server. According to investigators, Google reported the photos to NCMEC, who traced the account back to the man. Investigators then discovered an encrypted file containing explicit images of a child under the age of 5 on the man's **iCloud** account. The man pleaded guilty and was sentenced to prison.



## **[FED] Anchorage Motivational Speaker Indicted on Federal Child Pornography Charges**

June 25, 2020

### **Case Details:**

On February 14, 2020, a 41-year-old man was arrested and charged with sexual abuse of a minor and child porn possession. On June 25, 2020, he was federally charged with 2 counts of production of child pornography, 1 count of receipt of child pornography, and 1 count of coercion and enticement of a minor. According to Court records, investigators received a tip regarding the man's sexually inappropriate relationship with a minor, which included requesting and sending sexually explicit pictures and engaging in sexual contact. A search of the man's **iCloud** account revealed graphic communications between the two and several sexually explicit pictures of the minor.



## **[STATE] NJ State Troopers Arrested on Child Pornography Charges**

February 26, 2020

### **Case Details:**

On February 26, 2020, 2 state troopers — a 48-year-old man and a 35-year-old woman — were arrested and charged with distribution and possession of child pornography. The two individuals were charged with additional counts of possession and distribution of child sexual abuse material on September 24, 2021. The charges stemmed from an investigation that found CSAM in an [iCloud](#) account registered to the man.



## **[STATE] Tempe Man Arrested in Child Sexual Exploitation Investigation**

October 17, 2019

### **Case Details:**

On October 17, 2019, a 32-year-old man was arrested and charged with 13 counts of sexual exploitation of a minor-possession, sexual exploitation of a minor-recording, and sexual exploitation of a minor-distribution. Detectives found numerous explicit images of young children that had been on his cellphone, according to a probable cause statement submitted by police. After issuing a search warrant to **Apple**, police found multiple messages discussing a 5-year-old boy in a sexual context in his **iCloud** data. Investigators also collected 2,392 images and videos of sexual exploitation of a minor from the man's **iCloud** backups.



## **[FED] Philadelphia Man Sentenced to 20 Years in Prison Plus 20 Years of Supervised Release for Videotaping Children with Hidden Camera**

September 12, 2018

### **Case Details:**

A 38-year-old man was arrested on August 29, 2017 and charged with sexual abuse, corruption of minors, contact with a minor and invasion of privacy after the man's girlfriend discovered deleted videos of her 10 and 11-year old daughters in the bath on his phone. Additional investigation by law enforcement uncovered "hundreds of sexually explicit images" on the girls saved on his mobile phone, **iCloud** account, laptop, and in a spy watch. The man was sentenced to 20 years in prison on September 12, 2018 after pleading guilty to 9 counts of manufacturing and attempting to manufacture child pornography, and 1 count of possession of child pornography.



**Married Florida Private School Principal, 43, is Charged with Sexually Abusing Boy, 16, who Viewed her as a MOTHER FIGURE: 'Victim' Claims she Began Molesting him During Private Study Sessions**

April 19, 2023

**Case Details:**

On April 17, 2023, a 43-year-old private school principal was arrested and charged with 1 count of soliciting and engaging in sexual conduct by an authority figure. The woman's arrest came after a 16-year-old student told investigators that the principal touched him inappropriately.

According to an arrest report, the principal and the student engaged in "intimate talk" on iManage, including the exchange of semi-naked photos.



## **[FED] Illinois Man Pleads Guilty to Coercion and Enticement of a Minor**

September 14, 2022

### **Case Details:**

On September 14, 2022 — about 6 weeks after being released from prison in connection with a child pornography offense — a 25-year-old man pleaded guilty to coercion and enticement of a minor. The charges stem from his communications, including communications via [iMessage](#), with a 14-year-old girl. In those communications, the man “knowingly persuaded, induced, enticed and coerced the victim to take and send him, sexually explicit images and videos of herself” and asked that the victim call him “daddy.” The man had previously been convicted of child pornography offenses in Illinois. On January 18, 2023, the man was sentenced to 19 years in federal prison.



## **[FED] YouTube Singer Arrested on Child Pornography Charges**

June 14, 2017

### **Case Details:**

On May 4, 2019, a popular, 24-year-old YouTube singer was sentenced to 10 years in prison after pleading guilty to child pornography charges.

According to prosecutors, the man used **iMessage** to solicit sexually explicit videos of his 14 & 15-year-old female fans. In media coverage of his arrest, **Apple** did not immediately respond to request for comment, while other technology companies expressed their zero tolerance policy when it comes to CSAM.





## Ocala Man ‘Obsessed with Little Girls’ Arrested on Child Porn Charges

August 25, 2023

### Case Details:

On August 24, 2023, a 35-year-old man was arrested and charged with 20 counts of possessing CSAM. According to investigators, law enforcement received “nearly a dozen” tips from NCMEC indicating that the man was uploading CSAM to multiple social media platforms. In the course of the investigation, the man disclosed that he kept a “collection” of child pornography on his **iPhone 13** and computer for “personal and sexual gratification.” Investigators also noted that they found “over 1,000 videos depicting child pornography” on the man’s **iPhone**, including videos of the sexual abuse of prepubescent and toddler-aged girls. A majority of the girls in the videos were estimated to be between 5 and 8 years old.



## **Atlanta Man Gets Off Cruise in Miami, Gets Caught with Child Sex Abuse Clips, Police Say**

August 24, 2023

### **Case Details:**

On August 23, 2023, a 47-year-old man was arrested for possession of CSAM after customs agents located CSAM on his **iPhone**. According to police documents, the agents located 5 videos of child sexual abuse, including videos of boys as young as 8 being raped.



## **Florence Teen Faces Child Porn Charges**

August 23, 2023

### **Case Details:**

On March 22, 2023, a 19-year-old man was arrested and charged with 2 counts of possession of child pornography and 8 counts of distributing child pornography. The arrest came after law enforcement received a tip from NCMEC. Court documents indicate that after executing a search warrant and seizing the man's **iPhone**, investigators found files that “depicted girls between the ages of 5 and 15 engaged in a sex act or posed lasciviously.” The man pleaded not guilty on August 22, 2023.



## More Charges Filed in Child Porn Case

August 10, 2023

### Case Details:

On July 17, 2023, a 24-year-old man was detained after an acquaintance of his found him with her undressed 3-year-old while his **iPhone** appeared to be recording. He provided an **iPhone** to police who arrived on the scene, but officers said that he had another **iPhone** in his pocket that he was “very protective” of. According to court records, police found 290 image and video files of “prepubescent child pornography” on the man’s **iPhone** XR, 43 of which were made by the man using the phone. Those files also included 15 videos and 19 pictures of a 4-year-old boy who had been sexually assaulted by the man, some of which the man live-streamed. The files also included 3 videos and 6 photos involving a 3-year-old girl.

The police also found 79 images and 15 videos of “prepubescent child pornography” on the man’s **iPhone** 14 Pro. At least 2 of those videos showed prepubescent children committing sex acts with animals.

On August 10, 2023, the man was charged with 104 counts, including involuntary deviate sexual intercourse with a child, indecent assault of a person less than 13 years of age, corruption of minors,



photograph/film/depict on computer sex act with a child, child  
pornography, indecent assault of a person less than 13 years of age, and  
design/copy obscene material depicting a minor.

The man is currently being held on \$750,000.00 bail.



## **KC Man Pleads Guilty to Sexual Abuse of Child Victim, Distributing Video of Abuse Online**

August 8, 2023

### **Case Details:**

On August 8, 2023, a 32-year-old man pleaded guilty to crimes involving the sexual abuse of a 7-year-old victim. In connecting with his plea, the man admitted to using his **iPhone** to record an image and 2 video recordings capturing his sexual abuse of the child. He also admitted to distributing 1 of those videos online. The man was in possession of hundreds of images and videos containing CSAM at the time of his arrest in February of 2023.



## **Bluefield Men Arrested on Charges including Possession of Child Sexual Abuse Material**

July 27, 2023

### **Case Details:**

On July 25, 2023, a 22-year-old man was arrested and charged with 600 counts of possession of CSAM, 8 counts of solicitation of a minor via computer, and 3 counts of causing/assisting minors in filming sexually explicit conduct. The investigation into the man started after law enforcement received a tip from NCMEC. While police were interviewing the man, he admitted to “receipt, distribution and possession of CSAM” and stated that his **iPhone 11 Max** contained CSAM. He also admitted to actively engaging in the solicitation of explicit photographs from minors and engaging in explicit conversations with minors.



## **Farley Man Sentenced for Sexually Assaulting Minor Victim to Produce, Distribute Child Pornography**

July 27, 2023

### **Case Details:**

On July 27, 2023, a 36-year-old man was sentenced to 40 years in federal prison without parole for producing and distributing child pornography. The charges stem from the man's sexual assault of a 3-year-old victim in order to produce child pornography, which he distributed online. In some instances, he livestreamed the abuse to his "customers." A search of the man's **iPhone** uncovered 218 images and videos of child pornography.





## **Dangerous Man Calculated and Planned' Abuse of Young Child**

July 26, 2023

### **Case Details:**

On July 26, 2023, a 33-year-old man was convicted for multiple counts of sexual assault by touching, engaging in sexual activity in the presence of a child, possession of indecent images, distribution of indecent images, and possession of extreme pornography. Following a tip from the FBI, investigators searched the man's **iPhone** and found 160 images and videos of CSAM, including files showing the "violent rape" of babies just a few months old. The phone also contained videos of the man sexually assaulting a child victim, which he shared with others online.



## **Gladstone Couple Sentenced for Producing, Distributing Child Pornography**

July 26, 2023

### **Case Details:**

On July 26, 2023, a married couple was sentenced to prison in connection with the production, distribution, and receipt of child pornography over the internet. The husband, aged 47, was sentenced to 264 months in prison; the wife, aged 38, was sentenced to 84 months in prison. The arrest stemmed from the FBI's discovery of a social media account linked to the husband containing videos depicting the "sadistic sexual exploitation, torture and abuse of a toddler." The FBI then searched the man's **iPhone** and found hundreds of images of child pornography, including videos featuring 2 of the couple's child victims.



## **Ex-Senedd Lobbyist Jailed for Child Abuse Images**

July 25, 2023

### **Case Details:**

On June 25, 2023, a 52-year-old man was sentenced and jailed for making and distributing indecent images. Law enforcement searched the man's **iPhone** and found 62 indecent images of children as young as 3, including 8 in the most serious category (Category A), and videos of children as young as 7.



## **Man Pleads Guilty to Seeking Violent Sex Abuse Images from Source in Thailand**

July 24, 2023

### **Case Details:**

On July 24, 2023, a 30-year-old man pleaded guilty to charges of child exploitation and transmission of child abuse material. The man connected with and paid a woman in Thailand to “source sexually violent content of children” in exchange for payment. After searching the man’s **iPhone** and laptop, law enforcement located “thumbnails of videos depicting prepubescent boys engaged in explicit acts.”



## **Marlboro Man Arrested for Child Pornography Offenses**

July 20, 2023

### **Case Details:**

On June 18, 2023, a 44-year-old man was arrested and charged with receipt, distribution, and possession of child pornography after law enforcement connected him to a social media profile used to receive and post child pornography. While searching the man's house, law enforcement confiscated his **iPhone**. A preliminary forensic examination of the phone revealed the presence of CSAM.



## **Man Caught with Child Porn, Told Agents his Message “Tienes CP?” Stood for Caldo de Pollo**

July 20, 2023

### **Case Details:**

On July 15, 2023, a man was arrested and charged with possession with intent to view material containing child pornography that had been transported by foreign commerce. While crossing the border, the man gave his **iPhone** to a US Customs and Border Protection officer for inspection. The officer searching the phone found videos of “prepubescent female children” on his phone. In total, the phone contained over 10 videos of child porn.



## **Former N.H. Lawmaker Facing Federal Charge in Daycare Child Porn Case**

July 18, 2023

### **Case Details:**

On July 18, 2023, a 39-year-old woman was charged with sexual exploitation of children and distribution of child pornography alongside her 38-year-old partner. According to court documents, the woman's partner took images of nude children from the daycare where she worked and sent them to her partner. A review of the partner's **iPhone** uncovered over 10,000 text messages between them, describing photos of children as well as explicit sexual conversations involving children.



## **‘Ridiculous’ Leeds Pervert Said Friends Planted Child-Abuse Video on his iPhone**

July 17, 2023

### **Case Details:**

On July 17, 2023, a 29-year-old man was sentenced to 21 months in jail after pleading guilty to possession and distribution of child pornography. The man was arrested in March of 2020 in an unrelated matter, leading to his iPhone being analyzed while he was in custody. Police then found a 3-minute video depicting a boy as young as 5 being abused on the man's iPhone.





## **Darwin Man who Created and Distributed Child Abuse Material of his Own Stepdaughter Pleads Guilty to 31 Offenses**

July 15, 2023

### **Case Details:**

On July 15, 2023, an Australian man pleaded guilty of charges related to the creation and distribution of CSAM involving his own stepdaughter. A forensic examination of the man's **iPhone** showed that he had recorded his stepdaughter using his phone and another camera and had shared it online. A source of all the man's electronic devices, including the **iPhone** and an **iPad**, turned up more than 500 videos and 3,000 images depicting abuse of his stepdaughter.



## **Oxford Man who Filmed Himself Sexually Abusing 2 Young Children Sentenced to 25 Years in Federal Prison**

July 12, 2023

### **Case Details:**

On July 12, 2023, a 22-year-old man was sentenced to 25 years in prison for sexual exploitation of 2 children. According to Court records, the man sexually abused 2 children, 1, a 7-year-old-boy, in April 2022 and the other, a toddler, in June 2022. The man recorded both instances of abuse on his **iPhone**, which he also distributed online.



## **Pudsey Man Terrified of Jail Told: ‘It’s Nothing Compared to What These Children Go Through’**

July 12, 2023

### **Case Details:**

On June 12, 2023, a 22-year-old man was sentenced in connection with charges of 5 counts of making indecent images. The man was arrested after police connected him to an IP address being used to upload CSAM. After searching the man’s **iPhone**, police uncovered over 100 images containing CSAM, including 20 images depicting the most serious images (“Category A” images).



## **Ballwin Man who Admitted to Sex with Minors Sentenced to 9+ Years in Prison for Distributing Child Pornography**

July 7, 2023

### **Case Details:**

On July 7, 2023, a 22-year-old man was sentenced to more than 9 years in prison after pleading guilty to distribution of child pornography. The man admitted to sending nude photos of himself to three 15-year-old girls and one 12-year-old girl, soliciting nude pictures of a 15-year-old girl, and having sex with two 15-year-old girls. He also recorded videos of himself having sex with 1 of the 15-year-old girls. The man's arrest came after 1 of his victims reported him to a school resource officer. A search of the man's **iPhone** uncovered pictures and videos of him with 1 of the victims.



## **Police: Lancaster Man Found to be in Possession of 75 Images Depicting Child Pornography**

July 6, 2023

### **Case Details:**

On July 6, 2023, a 36-year-old man was arrested and charged with 2 felony counts of sexual abuse of children and 1 felony count of criminal use of a communication facility. According to court records, police received a tip from NCMEC regarding the sharing of suspected child pornography that led police to the man. A search of the man's **iPhone** uncovered 11 images and 64 videos depicting child pornography.



## **Man Wanted in Nashville Child Porn Case is Jailed in Alexandria**

July 3, 2023

### **Case Details:**

On July 3, 2023, a 20-year-old man was arrested and charged with more than 100 counts of sexual exploitation of a minor. According to court records, police received a tip from NCMEC regarding images being uploaded to an account being controlled by the man. The man later admitted to receiving, downloading, and possessing a large number of images containing CSAM on his **iPhone**.



## **Ponte Vedra Medical Tech Sentenced to Over 6 Years in Prison for Distributing Child Abuse Videos**

June 29, 2023

### **Case Details:**

On June 29, 2023, a 43-year-old man was sentenced to over 6 years in prison after pleading guilty to distribution of child pornography. An investigation into the man was opened after a tip from NCMEC traced the source of an image containing CSAM to him. In the course of the investigation, police seized the man's **iPhone**, which was found to contain "2,000 images and at least 10 videos of CSAM."



## **AG: Altoona Man Uploaded Over 100 Photos of Child Porn to Online Services**

June 27, 2023

### **Case Details:**

On June 27, 2023, a 24-year-old man was arrested and charged with 6 felony counts of child pornography and 1 felony count of criminal use of a communication facility. The investigation began after law enforcement received multiple tips from NCMEC regarding uploads of CSAM that led them to the man. While executing a search warrant of the man's residence, police discovered the man trying to delete photos from his **iPhone** before he surrendered it. A forensic exam of the phone revealed 4 images of CSAM depicting children believed to be between the ages of 4 and 10. The man is alleged to have uploaded 103 images of CSAM in total.





## **Las Vegas Felon Sentenced to nearly 12 Years in Prison for Possession of Child Sexual Abuse Material**

June 27, 2023

### **Case Details:**

On June 27, 2023, a 52-year-old man was sentenced to just under 12 years in prison for possession of child pornography. According to court records, the man was already serving a previous sentence for possession of child pornography when corrections staff found an **iPhone** in the man's possession containing 179 images and 35 videos of CSAM, including depictions of children as young as toddlers. The man also admitted to distributing CSAM online.



## **St. Clair Couple Arrested for Exploiting and Producing Child Porn**

June 23, 2023

### **Case Details:**

On June 23, 2023, 2 men — aged 47 and 29 — were arrested and charged with sexual exploitation of children and production of child pornography. The arrests came after a tip was made to law enforcement. The tip alleged that the men shared images of themselves engaging in sexual acts with an 8-year-old boy. A forensic analysis of 1 of the men's **iPhone** revealed numerous instances of CSAM.



## **Former Jail Contractor Sentenced to more than 17 Years for Distributing Child Sexual Abuse Materials**

June 23, 2023

### **Case Details:**

On June 23, 2023, a 36-year-old man was sentenced to more than 17 years in prison after pleading guilty to distribution of child sexual abuse material. An investigation into the man was opened after a tip revealed that someone using the man's IP address had uploaded CSAM online. The man admitted to distributing CSAM online. A forensic review of the man's **iPhone** uncovered multiple files of CSAM, as well as chats discussing sexual abuse.



## **Blue Springs Man Sentenced to 27 Years for Conspiracy to Produce Child Pornography**

June 22, 2023

### **Case Details:**

On June 22, 2023, a 46-year-old man was sentenced to 27 years in prison after pleading guilty to 1 count of conspiracy to produce child pornography, 2 counts of receiving child pornography over the internet, 1 count of distributing child pornography over the internet, and 1 count of possessing child pornography. According to court documents, the man viewed video of a 7-year-old child being raped live. After seizing the man's **iPhone**, investigators found evidence of the receipt and distribution of child pornography as well as images of the 7-year-old victim.



## **Gloucester County Man Charged with Possession of Child Pornography**

June 21, 2023

### **Case Details:**

A 29-year-old man who was serving a term of home detention as part of a 2015 sentence related to possession of child pornography was arrested again on June 21, 2023. During a routine inspection, the man's probation officer searched the man's **iPhone**, which contained 86 files depicting CSAM.



## **Man Shared Sex Abuse Photos Showing Kids in Distress and in Pain**

June 21, 2023

### **Case Details:**

On June 21, 2023, a 66-year-old man was sentenced to 26 months in prison after being charged with possession of and distributing indecent images and possession of extreme pornography. During their investigation of the man, police seized his **iPhone** and found 244 indecent images, including 166 images showing “the most extreme kind of sexual abuse.”



## **Former Primary School Teacher Convicted for Child Sexual Abuse Offences**

June 20, 2023

### **Case Details:**

On August 9, 2023, a 35-year-old former schoolteacher charged with causing the sexual exploitation and abuse of a child, encouraging the rape of a child, causing a child to engage in sexual activity, arranging the sexual abuse of a child, and distributing, making, and possessing indecent images of children, was sentenced to 12 years imprisonment. An investigation discovered that the man had commissioned the sexual abuse of children abroad resulting in the abuse of children under the age of 13, which was also videotaped and photographed. A search of the man's electronic devices by law enforcement uncovered more than 120,000 images of children aged between 3 months and 13 years of age on his laptop, **iPhone**, and SD card.



## **District Man Sentenced for Possession of Child Pornography**

June 20, 2023

### **Case Details:**

On June 20, 2023, a 31-year-old man was sentenced to 168 months in prison after pleading guilty to possession of child pornography. The man was identified after he sent CSAM to himself via email. He has also distributed and requested CSAM via social media. A search of the man's electronic devices, including an **iPhone**, uncovered "voluminous CSAM."





## **East Windsor Man Sentenced to more than 33 Years in Federal Prison for Recording his Sexual Abuse of Minor**

June 14, 2023

### **Case Details:**

On June 14, 2023, a 54-year-old man was sentenced to more than 33 years in prison after pleading guilty to production and possession of child pornography. After receiving a tip from NCMEC identifying an account that was uploading CSAM online, law enforcement was able to trace the account to the man. They searched his electronic devices, including an **iPhone**, and found more than 1,000 images and videos containing CSAM. Included in those files were images and videos of the man sexually abusing a girl between the ages of 6 and 8.



## **Former Delaware School Administrator Sentenced to 9 Years in Prison on Child Pornography Charges**

June 3, 2023

### **Case Details:**

On June 2, 2023, a 54-year-old former school administrator was sentenced to 9 years in prison after pleading guilty to 1 count of dealing in child porn and 4 counts of sexual solicitation of a child. After receiving a tip from NCMEC identifying an account that was uploading CSAM online, law enforcement was able to trace the account to the man. A search of the man's **iPhone** uncovered nude images of young girls.



## **A Former Delco School Bus Driver was Sentenced to State Prison for Filming Upskirt Photos of Students**

June 2, 2023

### **Case Details:**

On June 2, 2023, a 71-year-old man was sentenced with prison time after pleading guilty to attempting to create child pornography, unlawful contact with minors, invasion of privacy, and related crimes. The man was a former bus driver, and girls noticed that he was holding his phone at his side as they got on and off the bus and reported the incidents to their parents. A search warrant executed at the man's house found more than 100 upskirt videos of female students, some as young as 6-years-old, who rode his bus. He recorded and stored the videos on his **iPhone**.



## Levittown Man Charged with Having Child Pornography

June 1, 2023

### **Case Details:**

On May 31, 2023, a 37-year-old man was charged with possession of child pornography and sexual abuse of children through the dissemination of pictures and video. After receiving a tip from NCMEC identifying an account that was uploading CSAM online, law enforcement was able to trace the account to the man. A search of the man's **iPhone** found CSAM that he had downloaded, including images of prepubescent females.



## **Stamford Man Charged with Child Exploitation Offenses**

May 24, 2023

### **Case Details:**

On May 24, 2023, a 56-year-old man was arrested and charged with child exploitation offenses. The man's arrest was the result of a minor female reporting that when she was 9 years old, the man had sexually assaulted her multiple times, including taking sexually explicit photos of her. After arresting the man, law enforcement officers searched his **iPhone**, where they uncovered sexually explicit images of the minor victim, as well as images of the man engaging in sexually explicit conduct with the victim.



## **Maryland Woman Sentenced to 108 Months in Prison for Distributing Child Pornography**

May 19, 2023

### **Case Details:**

On May 19, 2023, a 42-year-old woman was sentenced to 9 years in prison for distribution of child pornography. The arrest came after she showed CSAM to an acquaintance and told him that she was attracted to minors. Law enforcement offices searched the woman's **iPhone**, which found several images and videos of CSAM, including images depicting children as young as toddlers.



## **Aviemore Man Caught with Indecent Images of Children on iPhone**

May 16, 2023

### **Case Details:**

On May 16, 2023, a 23-year-old man pleaded guilty to possession of indecent images of children after admitting to downloading CSAM.

Following a tip, police searched the man's iPhone, which revealed 50 images of CSAM involving girls aged 4 to 13.



## **Kik Moderator Helps Fort Myers Police Find Man Accused of Sharing Child Porn**

May 8, 2023

### **Case Details:**

On May 3, 2023, a 22-year-old man was arrested and charged with 10 counts of possession of sexual performance by a child and 2 counts of transmission of child pornography. After receiving a tip from NCMEC identifying an account that was uploading CSAM online, law enforcement was able to trace the account to the man. Police discovered that the man had shared “27 files of child pornography (involving toddlers)” online. Videos containing CSAM were also found on the man’s **iPhone**.





## **Federal Jury Convicts Pocatello Man of Sexual Exploitation of a Child and Receipt of Child Pornography**

May 3, 2023

### **Case Details:**

On May 2, 2023, a 43-year-old man was convicted by a jury of 8 counts of sexual exploitation of a child and 3 counts of receipt of child pornography. According to testimony and evidence presented at trial, the man sexually abused the first victim, a minor child, for 6 years and recorded the abuse with his **iPhone**. After a second abuse victim came forward and the man's **iPhone** was searched, images of the first victim's abuse were found.



## **Camden County Man Sentenced to 10 Years in Prison for Distributing Child Pornography**

May 1, 2023

### **Case Details:**

On May 1, 2023, a 33-year-old man was sentenced to 10 years imprisonment after pleading guilty to 1 count of distribution of child pornography. After receiving a tip from NCMEC identifying an account that was uploading CSAM online, law enforcement was able to trace the account to the man. Law enforcement searched the man's **iPhone** and found multiple files of CSAM. Those images included CSAM featuring children between the ages of 5 and 15.



## **Ex-Morgan Stanely, Schwab Broker Arrested on Child Porn Charges**

April 21, 2023

### **Case Details:**

On April 5, 2023, a 61-year-old man was arrested and charged with 21 counts of possessing, controlling, viewing and/or depicting child pornography. The arrest came after police received a tip that “presumed child pornography” was detected in his email and that the man had viewed CSAM on his **iPhone**. After searching the man’s **iPhone**, police found 8 images of nude, prepubescent females on his **iPhone** photo album. Police also found evidence of the man sharing and receiving CSAM on his phone.



## **Former Private School Teacher and Private Tutor Sentenced to 25 Years for his Enticement of a Minor and Possession of Child Pornography**

April 19, 2023

### **Case Details:**

On April 19, 2023, a 72-year-old man was sentenced to 25 years in prison after pleading guilty to enticement of a minor to engage in sexual activity and possession of child pornography. According to court records, the man induced a 7-year-old victim he was tutoring to engage in sexually explicit conduct, which the man recorded on his **iPhone**. A search of the man's phone was found to contain hundreds of images of the victim, as well as CSAM depicting the abuse of other children. Police also discovered, in the course of the investigation, that the man had abused 2 other children for a prolonged period of time years before.



## **Casper Man Sentenced to 170 Years on 6 Counts of Child Pornography**

April 13, 2023

### **Case Details:**

On April 13, 2023, a 32-year-old man was sentenced to 170 years in prison after being convicted at trial of 6 child pornography counts, including 5 for coercing a 13-year-old girl to produce images and video of her abuse. The investigation began after the girl's mother took her to the emergency room after she behaved strangely after spending the night at the man's house. A search of the man's home and electronic devices then uncovered videos and images of the man abusing the minor victim, which he recorded on his **iPhone**.



## **Carthage Man Pleads Guilty to Child Pornography on Workplace Computer**

April 12, 2023

### **Case Details:**

On April 11, 2023, a 56-year-old man pleaded guilty to 1 count of receiving and distributing child pornography. The investigation into the man was opened after the director of IT at the man's former workplace discovered CSAM on the man's workplace-issued computer. The man admitted to law enforcement that he had downloaded nearly 10,000 images and 100 videos of CSAM to his workplace computer and had also downloaded CSAM videos to his workplace-issued **iPhone**. The man also admitted to viewing CSAM on his personal **iPhone**.



## **Former Bachelorette Contestant Joshua Tylerbest Arrested on Child Pornography Charges**

March 31, 2023

### **Case Details:**

On February 23, 2023, a 27-year-old man was arrested and charged with 15 felony counts of possession of materials showing a sexual performance by a child. According to court documents, an investigation into 50 images and/or videos containing CSAM that were uploaded to an upload account led investigators to the man. Police seized the man's **iPhone** and other electronic devices. A preliminary forensic investigation of those devices revealed at least 15 images that contain CSAM. The man entered a plea of not guilty; his case is ongoing.



## Photographers Plead Guilty to Child Abuse

March 24, 2023

### **Case Details:**

On April 4, 2023, a 30-year-old man pleaded guilty to 4 charges related to possessing child abuse material. The man, an amateur photographer, is alleged to have sexually abused a minor on multiple occasions during photoshoots. After seizing the man's **iPhone**, cameras, and computers, police found "more than 1,000 images and 120 videos showing 'prepubescent children' involved in or witnessing a sexual act...on his camera storage cards, computer, phones and cloud storage accounts."





## **Bronx Daycare Provider Charged with Sexual Exploitation of a Child and Production, Receipt and Distribution of Child Pornography**

March 10, 2023

### **Case Details:**

On March 10, 2023, a 32-year-old daycare provider was arrested and charged with 1 count each of sexual exploitation of a child, receipt and distribution of child pornography, and possession of child pornography. According to court documents, the man abused an 11-year-old minor who attended the daycare facility he operated. The man also recorded the abuse on his **iPhone**. A search of the man's home and electronic devices uncovered images and videos containing CSAM.



## **Pennsylvania AG Charges Clifton Heights Man with Possessing Child Pornography**

March 8, 2023

### **Case Details:**

On March 7, 2023, a 26-year-old man was arrested and charged with 2 counts of possession of child pornography and 1 count of criminal use of a communication facility. According to court records, the man was arrested after executing a search warrant and finding CSAM on the man's **iPhone**.



## **Alameda County Firefighter Indicted for Possession of Child Pornography**

March 7, 2023

### **Case Details:**

On March 2, 2023, a 42-year-old man was indicted on charges of possession of child pornography. According to the indictment, the man possessed images of child pornography on his **iPhone**, including images of prepubescent children. The investigation of the man followed a cyber tip from NCMEC.



## **Colchester Man who had Child Sex Abuse Image on iPhone Sentenced**

March 3, 2023

### **Case Details:**

On February 3, 2023, a 25-year-old man was convicted of crimes including possessing and distributing indecent images of children. According to court papers, the law enforcement seized the man's **iPhone**, which was found to contain CSAM and "sexually charged conversations about children."



## **Skegness Man who Shared Videos of Child Abuse Jailed**

February 17, 2023

### **Case Details:**

On February 17, 2023, a 21-year-old man was sentenced to over 6 years in prison for sexually abusing a 4-year-old girl and sharing videos of the assault online. The man was identified after sending the video to another offender. After searching the man's **iPhone**, law enforcement found 42 images of the 4-year-old victim and "355 other indecent photos and videos found in various folders and caches, including of children being raped." He had also uploaded hundreds of gigabytes of CSAM to a file-sharing app.



## **Evansville Man Sentenced to 8 Years in Federal Prison for Distributing Child Sexual Abuse Material via Kik**

February 6, 2023

### **Case Details:**

On February 6, 2023, a 39-year-old man was sentenced to 8 years in prison for distribution of child sex abuse material. The man's arrest was the result of a tip regarding the upload of 36 files containing CSAM by an account tied to the man. After executing a search warrant on the man's home and searching his **iPhone**, detectives found child sexual abuse material, including a video involving an infant less than 1-year-old. Additionally, during the search, the man admitted that he had distributed and received CSAM online on multiple occasions.



## **Fresno Man Sentenced to 5.5 Years in Prison for Receipt and Distribution of Child Pornography**

January 23, 2023

### **Case Details:**

On January 22, 2023, a 22-year-old man was sentenced to 5.5 years in prison for receipt and distribution of child pornography; he previously pleaded guilty to the same charge. According to court documents, the man received between 150 and 300 images, including video files using his **iPhone**. Those images included depictions of pre-pubescent minors and material that meets the definition of sadistic or masochistic conduct.



## **Joplin Man Pleads Guilty to Child Pornography**

January 23, 2023

### **Case Details:**

On January 21, 2022, a 32-year-old man was arrested after multiple online communications and uploads implicated the man in the sharing of CSAM online. According to court documents, the man admitted to law enforcement that he had viewed and distributed child pornography for at least 2 years. A preliminary examination of the man's **iPhone** revealed that he had sent suspected CSAM of children less than 5 years of age to another person through texts as well. The man pleaded guilty to 1 count of receiving and distributing child pornography on January 23, 2023.





## Former cop seeks dismissal of some child porn charges

January 18, 2023

### **Case Details:**

In May of 2021, a 41 year old former County police officer was arrested for 8 counts of possession of child pornography, 1 count of posing or exhibiting a child in a state of nudity or sexual contact, 1 count of photographing, videotaping or electronically surveilling the sexual or other intimate parts of a child. Authorities seized several of his electronic devices, including laptops, USB drives and an **iPhone XR**, all of which contained “tens of thousands of images of child pornography and child erotica”. He also allegedly set up a camera in his then girlfriend’s bathroom and took images of children; these were later found on his **iPhone**. He was sentenced to 4-5 years in state prison followed by probation for five years probation.



# **Israeli Dual Citizen Sentenced to Seven Years in Prison For Transmitting Sexually Explicit Video of a Minor**

January 16, 2023

## **Case Details:**

On September 29, 2022, a man was sentenced to seven years in prison for transmitting sexually explicit video of a minor. The man contacted a UC on an online messaging app and asked him sexually explicit questions about his nonexistent daughter, and then sent him sexually explicit and normal pictures of his alleged 4-year-old daughter whom he claimed he was sexually active with. On August 2, 2016, Israeli National Police detained him. It was revealed that he did not actually have a 4-year-old daughter, but used a commercially produced photograph to persuade people to send him CSAM online by acting like he had access to a child (purportedly his daughter). Forensic analysis of his **iPhone** revealed 23 images of CSAM.



## **St. Charles County Man Sentenced to 4+ Years in Prison for Downloading and Sharing Child Pornography**

January 6, 2023

### **Case Details:**

In October of 2023, a man pleaded guilty and was sentenced to 4+ years in prison for downloading and sharing child pornography. He was in the habit of using social media to send and receive CSAM. Following the Cybertip from NCMEC, police conducted a search of his home on June 15, 2021 and found 5400 images and 610 videos of CSAM on his **Apple iPhone.**



## **Omaha men sentenced 10, 20 years in prison for child porn charges**

January 5, 2023

### **Case Details:**

On January 5, 2023, two men aged 50 and 21 years old were sentenced to 20 and 10 years in prison respectively for receipt and distribution of child pornography. The 50 year old admitted to chatting online about sexual fantasies and had “unintentionally” received child porn during these chats. Forensic review of his devices revealed at least 38 images of CSAM. In 2017, the 21 year old admitted to viewing images and videos of child pornography. An **iPhone** and an **Apple MacBook Air** were seized from the 21 year old’s house during one investigation in October 2021. Investigators confirmed that videos and two images from his cell phone depicted sexual conduct involving children younger than 16 years old.



## **Former Wilkes student pleads guilty to possessing child sexual abuse materials**

December 8, 2022

### **Case Details:**

On December 28, 2022 former student and 23 year old man pleaded guilty for 5 counts of possession of child pornography. His **Apple iPhone 11**, which he admitted would have CSAM, was found in a preliminary examination to contain at least 28 images of child pornography and 27 depicting either indecent contact or prepubescence.



## **Teacher's Assistant Pleads Guilty to Production of Child Pornography**

December 27, 2022

### **Case Details:**

On December 27, 2022, a former teacher working with children aged 18 months to 10 years old pleaded guilty to the production of child pornography and was sentenced in federal court to 90 years in prison. Following the Cybertip from Dropbox, his **iPhone** was seized and was found to contain a “hidden folder with 19 additional videos” taken in the preschool classroom where he worked. Law enforcement also located over 1000 images of CSAM on his **iPhone** and other devices.



## **Noblesville Man Sentenced to over 10 Years in Federal Prison for Distributing Child Sexual Abuse Material**

December 21, 2022

### **Case Details:**

On December 21, 2022 a 34 year old man was sentenced to 121 months in prison with subsequent 10 years of supervised release for distributing and receiving CSAM. In January 2021, the Police Department received information from Meta that he had been using the application to “store and exchange images of child sexual abuse”, and that he had sent CSAM to the witness. His residence and found 17 video files and 1 image file of CSAM on his **Apple iPhone**. He possessed the CSAM between June 2020 and May 2021.



## **Somersworth Man Sentenced to 66 Months for Distribution and Possession of Child Sexual Abuse Materials**

December 19, 2022

### **Case Details:**

On December 19, 2022, a 46 year old man was sentenced to 66 months in federal prison, 5 years of supervised release, and a \$6,000 restitution payment for the distribution and possession of CSAM. Following him sending a 1-minute CSAM video to an undercover agent on September 23, 2021, law enforcement enacted a search warrant on his residence on October 13, 2021, and seized the electronics he had used to distribute and possess CSAM. Forensic analysis of his **iPhone**, as well as evidence received from an online cloud storage provider confirmed that he had been sharing CSAM through email, text message and social media applications.





## **Man had child abuse images on tablet and phone in Workington**

December 1, 2022

### **Case Details:**

On December 1, 2022 a 26 year old man pleaded guilty to Making 12 Category A indecent images of a child, making 7 Category B indecent images of a child, making 22 Category C indecent images of a child, and possessing 317 extreme pornographic images, which portrayed a person performing an act of intercourse with a dog, possessing a prohibited image of a child. In a search of Lee's home, police found an **iPhone** and a tablet containing images of CSAM accessed between 2015 and 2021.



## **Convicted Felon Going To Prison On New Child Pornography Charge**

November 22, 2022

### **Case Details:**

On November 22, 2022, a convicted felon and 50 year old man was sentenced to 15 years in prison for the receipt of child pornography. On May 19, 2021, an officer found 2 explicit videos depicting a 17-year-old female produced by him in October 2020 in the “recently deleted” folder of his **iPhone**; they also found internet history of at least one website containing child pornography. At the time of this arrest, he was on “federal supervised release from his previous conviction (in 2011) and a registered sex offender”.



## **Fulton Man Sentenced to 15 Years for Secretly Recording Teen Victims**

November 16, 2022

### **Case Details:**

On November 15, 2022, a 52 year old man was sentenced to 15 years in federal prison without parole for 1 count of attempting to produce child pornography. The man admitted to placing a hidden camera in the bedroom of one female victim, and another in the bathroom of a second. The SD card of the first camera contained multiple videos of the victim partially or completely nude in her bedroom. This was the second time he had installed a camera in her bedroom. His **iPhone** contained multiple images of the victims in various stages of undress.



## **Arkansas Man Sentenced To 20 Years In Federal Prison For Soliciting And Paying For The Production Of A Video Depicting A 9-Year-Old Child Being Molested**

November 1, 2022

### **Case Details:**

On November 1, 2022 a 27 year old man was sentenced to 20 years in federal prison, life term of supervised release, and \$71,000 in restitution to child victims for Coercing a minor to engage in sexually explicit conduct for the purpose of producing a visual depiction of such conduct (pleaded guilty on June 15, 2021). In December 2019, he was contacted by an undercover FBI agent who was posing as the parent of a 9-year-old girl. He sent the agent a picture of his genitalia, asked for sexually explicit images of the girl, and solicited a video of the agent sexually abusing his “daughter” in exchange for money. He continued this behavior for over a month, describing different methods the agent could use to send him the video, and even going so far as to send the agent a \$50 gift card as an advance, with indications that there would be ‘more to come’. He admitted to FBI agents that he had also solicited sexually explicit pictures from 3 other children on the internet, as well as viewed CSAM of infants. Forensic examination of his **iPhone** and computer revealed “more than 1,000 videos and 5,000 images” of CSAM.



## Ottawa County Man Indicted On Child Pornography Charges

October 26, 2022

### **Case Details:**

On October 26, 2022 a man was sentenced to 30 years in prison for the production and distribution of child pornography. Around September 19, 2022, the man used an **iPhone** to photograph, or attempt to photograph, the genital area of a 3-year-old child for sexual purposes. Around September 20, 2022, he distributed 4 images of CSAM using an internet-based messaging application.



## **Cheektowaga Man Charged With Possession Of More Than 200,000 Images Of Child Pornography**

October 13, 2022

### **Case Details:**

On October 13, 2024 a man was sentenced to 48 months in prison and 25 years supervised release for the possession of child pornography. On October 22, 2020, his laptop, flash drive and **iPhone** were seized.

Forensic examination of the devices yielded “over 230,000 images and 95 videos of child pornography”, including pre-pubescent minors and violent behavior.



## **Durham pedophile shared indecent images with other perverts and videoed child on his iPhone**

September 29, 2022

### **Case Details:**

On September 29, 2022 a man was sentenced to 18 months in jail, subject of a 10-year sexual harm prevention order, and a member of the sex offenders register for 10 years for making indecent images, distribution of indecent images, and voyeurism. Following a tip from Reddit regarding the upload of 2 Category B indecent images by the man, he was found in possession of 46 hours worth of Category A indecent videos of children on his **iPhone**, as well as 2 videos of young children that he had filmed himself, on June 9, 2022. In all, his **iPhone** contained 113 category A images and 9 videos, 128 category B images and 3 videos, and 457 category C images and 9 videos.



## Plainville Man Pleads Guilty to Child Exploitation Offenses

September 29, 2022

### **Case Details:**

On September 29, 2024 a man pleaded guilty for 1 count of production and 1 count of distribution of child pornography. Analysis of his electronic devices (including an [Apple iPhone X](#)) revealed that between June 2017 and February 2020, he recorded 29 minors in bathrooms and produced 391 lewd images out of the videos, which he then uploaded to the dark web.





## **St. Louis County Sex Offender Admits Second Child Pornography Offense**

September 26, 2022

### **Case Details:**

On September 26, 2022 a convicted sex offender was sentenced to 2 years in prison and a lifetime supervised release for the possession of child pornography. He had previously, in 2020, been convicted of having CSAM, and was sentenced to 2 years in prison and a lifetime of supervised release. Upon his release, a probation officer in charge of visiting him found unallowed electronic devices in Goodwin's house. He admitted to having over 882 images and 624 videos of child sex abuse on his **iPhone**, tablet and USB drive that he found on Telegram and the dark web.



## **Former Airman sentenced to five years in prison for child pornography**

September 21, 2022

### **Case Details:**

On September 21, 2022, a former Airman was sentenced to five years in prison for the distribution of child pornography. At the time of the receipt of the tips from Kik, the man was employed as a Technical Sergeant with the US Air Force. On May 8, 2020, State Police executed a search warrant at his residence and seized “multiple digital items” including an **iPhone**, a forensic analysis of which revealed CSAM. He admitted to using his phone and Kik to send 2 videos of CSAM, one of which contained a child between the ages of 1 and 3.



## Swansea Man Agrees to Plead Guilty to Child Pornography Offense

September 28, 2022

### **Case Details:**

On September 28, 2022, a man pleaded guilty and was sentenced to 10 years in prison and 5 years supervised release for 1 count of possession of child pornography. The abuser's **iPhone** and laptop were seized and found to contain CSAM, including videos depicting infants. He had previously been convicted of possession of child pornography in 2002.



## **Beloit Man Charged with Transporting Minor Across State Lines & Producing Child Pornography**

September 6, 2022

### **Case Details:**

On September 6, 2022, a man was charged and sentenced to 22 and ½ years in federal prison for transporting a minor across state lines with the intent that the minor engage in a sexual activity (second degree sexual assault of a child), and using the minor to engage in sexually explicit conduct for the purpose of producing a visual depiction of such conduct. The man transported a minor on March 19, 2021, and used an **iPhone** to produce child pornography (by committing second degree sexual assault on the minor) between January 2020 and September 2021.



## **Man guilty of possessing, sharing child porn on Kik**

July 7, 2022

### **Case Details:**

On July 7, 2022 a man was sentenced to 210 months of incarceration, \$16,000 in restitution to the victims, subsequent 15 years of supervised release, and registration as a sex offender. Investigation into the case was initiated following an undercover Sheriff's Office employee's observation of a certain Kik user uploading 2 videos depicting CSAM to a Kik chat group known to disseminate the same. The user was identified, and his **Apple iPhone 7 and Apple iPhone 11** were seized. He confessed that he had viewed CSAM on Kik, which he had been using since 2018, and that he had shared CSAM with another Kik user at least once. Forensic extraction of the **Apple iPhone 7** revealed 50 video files & 14 image files of CSAM, and that of the **Apple iPhone 11** revealed 1 video file & 2 image files of CSAM.



## **Lake County Man Sentenced To Life In Prison For Coercing, Engaging In Sexual Activity With A Child And Distributing Child Sexual Abuse Images Over The Internet**

June 15, 2022

### **Case Details:**

On June 22, 2022 a man was sentenced to life in federal prison, lifetime of supervised release, registration as a sex offender, \$24,797 in restitution to the victim, and forfeiture of the Apple iPhone used to commit the child sex offenses. The man, along with other individuals, sexually abused a prepubescent child in his care between 15 and 50 times while forcing the child to wear a blindfold. He contacted a registered sex offender on November 29, 2019, and made arrangements for him to also sexually assault the child in exchange for money to purchase a video game for the child. The pair committed the heinous crimes at least 6 times between 2017 and 2020, and on one occasion, he allowed a third person to participate. His **iPhone** revealed that he had also distributed and traded CSAM online, and a forensic examination of his devices revealed 6 videos and 47 images depicting CSAM of infants and prepubescent children.



## **Broward Pediatrician Sentenced to Prison for Child Porn Possession**

June 10, 2022

### **Case Details:**

On June 10th, 2022 a former pediatrician was sentenced to 8 years in prison, subsequent 15 years of supervised release, and registration as a sex offender for the possession of child pornography. He was arrested following a tip from Yahoo to NCMEC leading to his Yahoo account being searched; it contained a video of a 6-year-old being sexually abused by a man. The doctor's **iPhone** and computer also contained images of "young children and teens in their underwear, taken without their knowledge".



## **Stanton Harcourt man who groomed eight-year-olds on TikTok jailed**

June 9, 2022

### **Case Details:**

On June 9, 2022, a man was sentenced to 4 years in prison and indefinitely registered to the sex offender's list for 3 counts of making indecent images of children and 2 counts of inciting a girl under the age of 13 to engage in non-penetrative sexual activity. He groomed two 8-year-old girls through TikTok. He started coercing them to engage in online sexual activity between October and December 2021. Following detection, officers found 235 videos/images of CSAM on his **iPhone**, of which 95 belonged to Category A.





## **Coraopolis Man Pleads Guilty to Child Sexual Exploitation Charges**

June 2, 2022

### **Case Details:**

On June 2, 2022 a man pleaded guilty for 1 count of possession of material depicting the sexual exploitation of a minor. On September 26, 2018, law enforcement conducted a residential search and seized a computer and an **Apple iPhone**, which together contained a total of 120 videos and 9 still images of CSAM depicting minor females.



## **Stratford Man Charged with Child Exploitation Offenses, Victimizing Teen Through Snapchat**

May 4, 2022

### **Case Details:**

On May 4, 2022, a man was sentenced to 11 years in prison for the enticement of a minor to engage in illegal sexual activity, receipt of child pornography, and possession of child pornography. He used Snapchat, Omegle and FaceTime to interact with minors (13-year-olds and 14-year-olds) and coerce them into engaging in sexual activity. On May 24, 2021, his **iPhone** revealed “videos of prepubescent children being sexually abused”.



## **Kentucky child pornography investigation results in arrest of 2 men, including a Hardin County teacher**

April 22, 2022

### **Case Details:**

On April 22, 2022 a man was sentenced to 25 years in federal prison for 100 counts of possession or viewing of matter portraying a sexual performance by a minor, 1 count of the prohibited use of an electronic communications system to procure a minor or peace officer for sexual offenses, 2 counts of the use of a minor (under 18) in a sexual performance, and 2 counts of distribution of matter portraying a sexual performance by a minor. On April 30, 2018, he sent another man at least 2 images of CSAM of boys between the ages of 12 and 14 via text messages. They had also exchanged CSAM in 2018 via chat. On February 16, he contacted a 16-year-old boy online and solicited sexual images of him, which the boy sent. By April 9, he had over 1500 images/videos of CSAM in a password-protected app on his **iPhone**.



## **Greece Man With Prior Child Sexual Abuse Conviction Going To Prison On Child Pornography Charge**

April 18, 2022

### **Case Details:**

On April 18, 2022 a man was sentenced to 10 years in prison and 15 years of supervised release for the possession of child pornography. On May 20, 2019, the man possessed 20 images of CSAM on his **iPhone**, with some depicting prepubescent minors under the age of 12. He had been previously convicted on July 31, 2003 of sexual abuse of a child under the age of 11.



## **Nashua Man Pleads Guilty to Possession of Child Sexual Abuse Material**

April 6, 2022

### **Case Details:**

On April 6, 2022 a man pleaded guilty to the possession of CSAM. The investigation into the perpetrator began in June 2018 following an individual's report to the Police Department regarding potential CSAM. The individual had lent their **iPhone** to another person, and after its return had found "an email containing four videos that showed him masturbating while standing over a sleeping child". The child in the videos was 5 years old when they were taken; Dukette admitted to making and keeping the videos.



## **Harford County Felon Pleads Guilty to Sexual Exploitation of a Child to Produce Child Pornography and to Illegal Possession of a Firearm and Ammunition**

April 1, 2022

### **Case Details:**

On April 1, 2022 a former felon pleaded guilty to sexual exploitation of a child to produce child pornography. He was sentenced to 15 years in federal prison, 25 years of supervised release, and registration as a sex offender. On November 30, 2020, County Sheriff's deputies executed a search warrant at the perpetrator's residence on a firearm related offense and seized his **Apple iPhone 7, Apple Watch** and firearm. His **Apple iPhone 7** revealed 3 sexually explicit videos of a 12-year-old victim Jane Doe: one depicting him sexually abusing her while she was sleeping, and one hidden from her and recording her undressing and getting into and out of the shower.



## **Martinsburg man sentenced for child pornography charge**

March 28, 2022

### **Case Details:**

On March 28, 2022, a man was sentenced to 97 months of incarceration, 40 years of supervised release, and \$55,000 in restitution for 1 count of possession of child pornography. The man admitted to uploading CSAM to Kik in May 2020 and possessing an image of CSAM depicting a child under the age of 12 in October 2020. State Police seized his **iPhone** in October 2020 and found more than 3,300 images and 52 videos of CSAM on his iPhone.



## **Taney County Couple Sentenced for Sexually Assaulting Children, Child Pornography**

March 17, 2022

### **Case Details:**

On March 17, 2022 UK citizens and legal residents of the United States were sentenced to 35 years in federal prison without parole and subsequent lifetime of supervised release for 1 count of the sexual exploitation of minors and 1 count of receiving and distributing child pornography. Forensic analysis of the abusers' **iPhones** revealed videos of them sexually assaulting a 2-year-old and a 4-year-old respectively, as well as other images and videos depicting child pornography. They admitted to using a social media application to share child porn, and to watching it on the internet.





## North Tonawanda Man Pleads Guilty to Child Pornography Charge

January 28, 2022

### **Case Details:**

On January 28, 2022 a man pleaded guilty for the possession of child pornography involving a pre-pubescent minor. In October 2019, the abuse uploaded an image of CSAM to Discord. On December 17, 2019, investigators executed a search warrant at his residence and seized 7 electronic devices including his **iPhone**. Forensic analysis of the **iPhone** revealed “4,204 image files of child pornography and 8,523 images of child exploitative material, a majority of which depicted minors under the age of 12”. His **iPhone** also revealed deleted Kik and Snapchat conversations with a 15-year-old female in which he solicited nudes. On February 5, 2020, another search warrant was executed at Ostrowski’s residence and a computer with CSAM was found.



## **Norwich Man Sentenced to 23 Years in Federal Prison for Recording his Repeated Sexual Abuse of Child**

January 24, 2022

### **Case Details:**

On January 21, 2022, a man was sentenced to 23 years of imprisonment and 5 years of subsequent supervised release for 1 count of production of child pornography and 1 count of distribution of child pornography. On more than 100 occasions, he sexually abused a 9-year-old child; in July 2019, he took pictures of himself abusing the child with his **iPhone**, even going so far as to film 10 videos depicting him sexually abusing the child on July 27, 2019. He sent the images to a woman via text message. In the text message conversations, he also told the woman that he wanted to engage in sexual activity with her when the child was watching, and desired the child to take part too.



## **Judge sentences Missouri man for the receipt of child pornography**

January 13, 2022

### **Case Details:**

On January 13, 2022 a judge sentenced a man to 72 months in federal prison with lifetime of supervised release for the receipt of child pornography. On November 26, 2019, a social networking application reported that an account belonging to the abuser had uploaded 26 images of CSAM. On June 10, 2020, law enforcement executed a search warrant at his residence & seized multiple electronic devices. He additionally provided them with his **Apple iPhone** and the associated password and admitted to having been downloading CSAM from the internet for the preceding 4-5 years. Law enforcement found 2,398 images and 101 videos of CSAM on the **iPhone**, as well as conversations with people on Kik wherein he discussed his attraction to children and traded CSAM.



## **Citrus Heights Man Sentenced to over 24 Years in Prison for Sexual Exploitation of a Child**

January 6, 2022

### **Case Details:**

On January 6, 2022 a man was sentenced to 24 years and 4 months in prison following 20 years of supervised release for the sexual exploitation of a child. He sexually abused a 13-year-old child victim for months. He recorded/photographed the same and shared at least 1 video of the victim engaging in sexually explicit activity to another person in exchange for CSAM of other victims. Over 200 videos of CSAM, some depicting children as young as toddlers, were found on his **iPhone**.



## **Former Teacher Sentenced to 5 Years in Federal Prison for Recording Inappropriate Video of his Students**

December 16, 2021

### **Case Details:**

On December 16, 2021 a former teacher was sentenced to 60 months in federal prison, 15 years of supervised release, and \$5,000 special assessment to a victim assistance fund for child pornography and human trafficking victims for attempted receipt of child pornography, video voyeurism, obstruction of justice by corruptly destroying records, documents, or other objects. On August 25, 2020, the former teacher was observed by a witness walking very closely behind the victim and holding his iPhone under her skirt for several seconds. The witness also noticed the red recording button and timer indicating that the phone was recording. Following her report to the police, he was held in a room until law enforcement arrived, and utilized that time to delete photographs and videos from his phone, making them unrecoverable. He later admitted that between August 1, 2019, and August 25, 2020, he used his **iPhone** to record and receive images of the victim's and other students' pubic areas.



## **Pevely man sentenced to 25 years in prison for producing child pornography**

December 16, 2021

### **Case Details:**

On December 16, 2024 a man was sentenced to 25 years in prison for the production of child pornography. On August 29, 2020, the man responded to an advertisement posted by an undercover law enforcement officer on an online platform describing his interest in engaging in sexual activity with the underage female whom he believed he was conversing with. The same day, he traveled to Missouri expecting to meet the underage female and engage in sexual contact with her but was arrested instead. Police also determined that Jackson and a co-defendant had been abusing a minor together — they had used an **Apple iPhone** to record the abuse, created 10 images of it, and shared them on the internet.



## **Watertown Man Sentenced for Possession of Child Pornography**

December 9, 2021

### **Case Details:**

On December 9, 2021 a man was sentenced to 72 months in federal prison, 5 years of supervised release, \$5,000 fine, and \$100 special assessment to the Federal Crime Victims Fund for receipt, distribution, transportation and possession of child pornography. Between May 1, 2017 and May 5, 2020, the abuser possessed graphic image and video files depicting minors engaged in sexually explicit conduct. He used his **Apple iPhone 8** to download the files from the internet.



## **Federal Jury Convicts Former Reality Television Personality for Downloading and Possessing Child Sexual Abuse Material**

December 9, 2021

### **Case Details:**

On December 9, 2021, former reality television personality was sentenced to more than 12 years in federal prison for the receipt and possession of child pornography. He “downloaded and viewed images and videos depicting the sexual abuse of children, including images of prepubescent children and depictions of sadistic abuse.” He downloaded the material using the dark web onto a password-protected partition on his hard drive, viewed it, and then deleted it from his device, multiple times over the course of 3 days in May 2019. He accessed the device from his used car lot. “Significant evidence was found that pointed to his presence at the times of the offenses, including pictures that he took on his phone that geolocated at or near the car lot. He also sent multiple timestamped text messages to various individuals that indicated he was at the car lot at the relevant times; the messages were sent, and the **iPhone** pictures were created, at times within minutes of when the child sexual abuse material was downloaded or displayed on the desktop computer.”





## **Cincinnati Man Sentenced to 192 Months for Production of Child Pornography**

September 24, 2021

### **Case Details:**

On September 24, 2024, a man was sentenced to 192 months for production of child pornography. On August 8, 2020, the man traveled to engage in sexual conduct with a minor. He recorded the abuse on his **iPhone** and sent it to the minor via Instagram.



## **Branford Sex Offender Pleads Guilty to Possessing Child Sex Abuse Images**

September 9, 2021

### **Case Details:**

On September 9, 2021, a sex offender pleaded guilty to 1 count of possession of child pornography. He was sentenced to 156 months of imprisonment, 10 years of supervised release, and \$29,000 in restitution to victims. Between September 1, 2014, and March 8, 2021, he possessed CSAM on both his **iPhone** as well as his Dropbox account. He also shared and sometimes received CSAM using chat applications. A review of his **iPhone** and online accounts revealed “at least 142 unique image files and 118 unique video files of child pornography, including images and videos depicting the sexual abuse of infants and toddlers.” He was already convicted of a similar crime in August 2011 and performed some of the aforementioned activities when on supervised release for the previous crime.



## **Former UNL Student Convicted for Receipt of Child Pornography**

August 27, 2021

### **Case Details:**

On August 27, 2021 a former student was sentenced to 10 years and 4 months in prison, 15 years of supervised release, and \$18,000 restitution for the receipt of child pornography. The investigation into him began on September 9, 2020, following his interview with the PD on an unrelated matter, during which they found CSAM on his **iPhone 8 Plus** photo gallery in the process of consensually viewing it. They later discovered that he had been the primary suspect in an investigation of 2 Cybertips received from NCMEC in April 2020. During that investigation, he had admitted to sharing CSAM images and promised to stop and seek medical assistance. A forensic download of his **iPhone 8 Plus** revealed 1,323 videos and 48 images of CSAM. It was also discovered that he had attempted to trade CSAM on Instagram.



## **Man Arrested for Child Pornography and Illegally Filming Women**

August 12, 2021

### **Case Details:**

On August 12, 2021, a man was arrested and charged with 83 felony counts of possessing child pornography, 5 counts of invasion of privacy, and the criminal use of a communications facility. The tip was received from Dropbox. Forensic examination of seized devices (including a laptop, **iPhone** and a small concealable camera) “more than 100 videos or still images that depicted child pornography with at least 10 of the photo/video files depicting children under the age of 13 being sexually assaulted.”



## **Suspended judge to plead guilty in federal child porn case**

August 6, 2021

### **Case Details:**

On September 28, 2021 a former children's court judge was found guilty of 7 counts of possession of child pornography (pled guilty on August 2, 2021) and the distribution of child pornography (pleaded guilty on September 28, 2021). He was sentenced to 9 years in prison and 20 years of supervised release. He pled guilty to **“using an iPhone to send sexually explicit images of children”** to another Kik user on the platform in October 2020.



## **Wolcott Man Arrested, Charged With Receipt And Possession Of Child Pornography**

May 25, 2021

### **Case Details:**

On August 10th, 2022, a man was sentenced to over 8 years in prison for the possession and receipt of child pornography. On October 19, 2020, police found **2 iPhones**, and a damaged computer tower in his residence. The **iPhone** revealed explicit Snapchat messages between the perpetrator and a 13-year-old, while the computer revealed 69 images and 13 videos of child pornography.



## **Former Orange County Social Worker Who Distributed Child Pornography Videos Sentenced to 8 Years in Federal Prison**

April 19, 2021

### **Case Details:**

On April 19, 2021 former social worker was sentenced to 96 months in federal prison and \$40,000 in restitution to the victims for 1 count of distribution of child pornography. The abuser, who worked at a Social Services Agency and had the privilege of assessing applicants' suitability to care for children in protective custody, and placing children in homes (among other responsibilities), distributed 3 video files of CSAM to an undercover law enforcement officer in November 2019. He also posted the link to a web page containing 3 videos of CSAM. He admitted that in January 2020 he had possessed an **Apple iPhone**, as well as other devices, and that together they had contained "at least 1,027 videos and 914 images of CSAM". He also possessed videos of minors undressing from LiveMe, as well as those of minors in public.



## **Newport paedophile had images of young children being raped**

April 11, 2021

### **Case Details:**

On April 11, 2021 a man was sentenced to 10 months' imprisonment, 18 months' suspension, 150 hours of unpaid work, attendance of a sex offender rehabilitation program, registration as a sex offender for 10 years, and subject of a sexual harm prevention order until 2031€ and 156 victim surcharge for the possession of indecent images of children. On May 13, 2020, police discovered 199 indecent images of children on his black **iPhone** (which he provided the pin to), of which 41 belonged to Category A, 72 belonged to Category B, and the remaining belonged to Category C. He had previously been convicted for indecent exposure.





## **Youth Pastor Charged With Production of Child Pornography**

April 9, 2021

### **Case Details:**

A former youth pastor was charged with the production of child pornography and was sentenced to more than seven years in federal prison. In July 2019, the 12-year-old victim had attended a Christian music festival and had been invited by the Pastor to change her clothes in his camper. After changing, she discovered 2 hidden **iPhones** that had been recording her actions and after deleting them, she called her mother who informed the County Sheriff's Office. He was charged with Unlawful Surveillance in the Second Degree and sentenced. His cell phones were later found to contain CSAM images and videos.



## **Stratford Man Admits Producing and Distributing Child Pornography**

March 11, 2021

### **Case Details:**

On May 20, 2022 a man was sentenced to 216 months of imprisonment and 10 years of supervised release for 2 counts of production of child pornography and 2 counts of distribution of child pornography. The man was the administrator of a private Kik chat group and in that role distributed and requested child pornography, as well as removed from the group members who did not share the contraband. He also contacted underage girls on Instagram, met up with them to engage in sexually explicit activity (which he then recorded and posted on Kik) or solicited sexually explicit videos and images from them that he non-consensually saved. In one case, he used a spy camera to record a minor girl undressing and shared it on Kik. He was arrested on June 25, 2020 as part of a sting operation, and his **iPhone** was seized. Forensic analysis of the device revealed “nearly 2,000 child sexual abuse videos and images, including videos and images that he had produced”.
